## **MS – Information Technology Business Analysis**

## **Plan of Study Overview**

The MS with a focus in Information Technology Business Analysis is 100% online. The flexible MS requires 34 credit-hours (only 30 credit-hours if you're already certified in Business Analysis) and can take 2-4 years to complete, depending on your schedule. All of your course activities, assignments, and exams must be completed by their respective due dates. You will need to view course lectures regularly to keep current. The length of our courses are offered in 8-week Modules each spring, summer and fall.

As a Purdue graduate student you will be taking classes in an online environment. Instructors provide the material, lectures, tests and assignments that can be accessed at any time on Purdue's Platform, **Brightspace**. Your lectures are not time restricted, meaning you don't need to be logged in to preview your course material at a specific time.

- Purdue courses that are more than five years old may not be used on a Plan of Study (POS).
- Late submission of the Plan of Study, late addition to the Graduate School Candidate list, or being on the Candidate list more than two consecutive sessions will result in a \$200 late fee.
- If credits are transferring in from one of the stackable certificates, let us know.
